# INDO INTERNATIONAL TOURISM CHAMBER OF COMMERCE (IITCC)

## 1. Introduction

These Terms and Conditions govern membership, participation, and activities organized by the Indo International Tourism Chamber of Commerce (IITCC). By becoming a member, using IITCC services, or participating in its programs, you agree to comply with the terms outlined below. These terms apply to all members, partners, affiliates, and participants of the Chamber.

## 2. Membership Categories and Fees

#### 2. Allied Members

- Domestic Operators with intention to start Inbound/Outbound business
- Must undergo Tourism Training Program and obtain approval from the Selection Committee.

#### 3. International Members

- Tour Operators, DMCs, or Travel Service Providers based overseas

#### 4. Affiliate Members

- Tourism Boards, Airlines, Hoteliers, Cruises, Transport Companies, Educational Institutes, Tourism Tech Firms.

#### 5. Student Members

- Enrolled in affiliated tourism training programs, non-voting

#### 6. Honorary Members

- Invited Guests and VIPs, as decided by the Governing Body

### 3. Membership Eligibility and Rights

Membership is open to individuals and organizations involved in tourism, hospitality, travel, and allied sectors. Members are entitled to participate in IITCC's programs, events, and initiatives. Each member must comply with IITCC's code of conduct and uphold the chamber's reputation.

### 4. Objectives of IITCC

The objectives of IITCC, as outlined in its charter, include the following:

- • Establish mentorship programs for aspiring entrepreneurs and create job-ready training initiatives in collaboration with educational institutions.
- • Develop a Fraud Management Cell to support members with legal and advisory services against fraudulent activities.
- • Create specialized committees for Inbound, Outbound, MICE, Education, Membership, PR, Finance, Technology, and Ethics.
- • Represent tourism stakeholders before government bodies for advocacy and policy formulation.

## **5. Code of Conduct**

Members are expected to maintain professionalism, integrity, and ethical behavior in all IITCC-related engagements. Any form of misconduct, fraud, or misrepresentation may result in suspension or termination of membership.

## **6. Event Participation**

IITCC organizes trade fairs, conclaves, training sessions, and networking events for members. Participation may require registration and payment of applicable fees. IITCC reserves the right to modify event details or cancel events if necessary.

## **7. Data Protection and Privacy**

All personal and organizational data shared with IITCC will be managed in accordance with the Chamber's Privacy Policy. Members consent to the collection and use of their information for legitimate business and networking purposes.

## **8. Termination and Suspension of Membership**

Membership may be terminated or suspended due to non-payment, breach of terms, unethical conduct, or at the member's written request. Decisions regarding termination are final and binding as per IITCC's governing council's discretion.

## **9. Limitation of Liability**

IITCC shall not be liable for any losses, damages, or claims arising from participation in chamber activities. Members are responsible for their own professional and business conduct.
